A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO JETTI SUPPLY DISTRIBUTION, INC., FOR THE CONSTRUCTION OF A GASOLINE SERVICE STATION LOCATED AT MINDANAO AVENUE, CORNER ROAD 16, BARANGAY BAGONG PAG-ASA, QUEZON CITY.


WHEREAS, petitioner Jetti Supply Distribution, Inc., a duly registered juridical entity herein represented by their Vice President Pepito A. Quijano, is applying for the issuance of a Special Use Permit (SUP) for the construction of one of its gasoline service stations to be located at Mindanao Avenue corner Road 16, Barangay Bagong Pag-Asa, Quezon City, classified as a Major Commercial (C-2) Zone, as part of the expansion program of its facilities in Quezon City;

WHEREAS, filling stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Jetti Supply Distribution, Inc., has complied with the requirements for the issuance of a Special Use Permit as required by said Ordinance;

WHEREAS, the construction and operation of gasoline service station will promote public welfare and economic development, through the projected increase of employment opportunities in our city.
