A RESOLUTION REQUESTING THE CITY ENGINEER TO UPDATE AND SUBMIT ALL THE STUDIES AND RECOMMENDATIONS ON THE IMPROVEMENT OF THE DRAINAGE AND SEWERAGE SYSTEM OF THE ENTIRE QUEZON CITY.

WHEREAS, despite the fact that it is situated in an elevated position, much higher than most surrounding cities and municipalities, Quezon City continues to suffer from flooding even after only short torrential rains, with the water in some areas remaining for days;

WHEREAS, the drainage and sewerage system of the City is proven inadequate to cope with the rush of water during rainy months, aggravated by illegal structures constructed on creeks and rivers;

WHEREAS, the growth in the City's population, coupled with the growth of commercial and other economic activities, calls for re-evaluation of its drainage and sewerage system.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the City Engineer to update and submit all the studies and recommendation on the improvement of the drainage and sewerage system of the entire Quezon City;
