BELMONTE, JR., CITY MAYOR, THIS CITY, AND PHILAND SECURITY AND DETECTIVE AGENCY, INC., REPRESENTED BY MR. FELICITO A. VALMOCINA, CEO/GENERAL MANAGER, ON FEBRUARY 16, 2002, FOR THE PERIOD COVERING FEBRUARY 16, TO MAY 31, 2002.

WHEREAS, the Quezon City Government has been holding sensitive offices outside the city hall compound which need the services of security guards in order to maintain peace and order situation in its premises, as well as to protect the well being of its employees and properties;

WHEREAS, aware of such need the Honorable City Mayor Feliciano R. Belmonte, Jr., have engaged the services of Philand Security and Detective Agency, Inc., to undertake the responsibility;

WHEREAS, Philand Security Agency, Inc., on its part is a duly licensed and authorized security agency having existed by virtue of Republic Act 5487, otherwise known as the Private Security Act and a holder of National License No. PSA-01195-2001, issued by the Philippine National Police (PNP) with principal address at No. 230 St. Peter Street, Barangay Holy Spirit, Quezon City;

WHEREAS, the Contract for Security Service was signed by the parties last February 16 up to May 31, 2002;


WHEREAS, the Contract for Security Service entered into by the parties requires the ratification of the Quezon City Council.
