**A RESOLUTION AUTHORIZING THE HONORABLE MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT FOR THE UPGRADING OF THE THREE (3) ELEVATOR UNITS IN QUEZON CITY HALL.**

WHEREAS, there are, at present, three (3) existing passenger elevators of the main Quezon City Hall Building servicing thousands of taxpayers, employees, officials, visitors and guests everyday;

WHEREAS, serious safety and reliability concerns have been observed and raised regarding the continued operation of this elevator system for the past several years;


WHEREAS, the City Accountant has obligated the amount of THIRTEEN MILLION EIGHT HUNDRED FIFTY-FIVE THOUSAND PESOS (P13,855,000.00), Philippine Currency, for the upgrade of this elevator system;

WHEREAS, in the paramount interest of public safety and service, it is imperative that this elevator system be immediately upgraded without further delay by the Office of the City Mayor.


NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract for the immediate upgrading of this elevator system, including but not limited to the supply and installation of three (3) units of elevators and dismantling of existing units, and related civil works, at a price and under such terms and conditions most advantageous to and beneficial to the Quezon City Government.
