## RESOLUTION NO. SP-191,6-2002

A RESOLUTION STRONGLY URGING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO INSTALL ONE (1) ARTESIAN WELL AT KAINGIN BUKID, BARANGAY APOLONIO SAMSON, DISTRICT II, QUEZON CITY.

WHEREAS, the people of Kaingin Bukid, Barangay Apolonio Samson, District II of this city has signified the importance of installing one artesian well within the said area through a letter addressed to this humble representative;

WHEREAS, one of the pre-requisites to orderly and well-balanced growth of depressed urban areas is an effective system of local water utilities, the absence of which is recognized as deterrent to economic growth, a hazard to public health, an irritant to the spirit and well being of the citizenry;

WHEREAS, domestic urban water system sanitary services are two of the most essential elements of local water utility system, which do not exist in depressed areas of Kaingin, Bukid Barangay Apolonio;

WHEREAS, said artesian well installation could pave the way for a convenient water supply most particularly at Kaingin Bukid, Barangay Apolonio Samson, considering that water from MWSI hardly reaches the above cited areas.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Honorable City Mayor, Feliciano R. Belmonte, Jr., to install one (1) unit artesian well at Kaingin Bukid, Barangay Apolonio Samson, District II, Quezon City.
