RESOLUTION NO. SP-**1918**S-2002

A RESOLUTION GRANTING SPECIAL PERMIT TO THE GALLERA DE GUISON HERMANOS, INC. (LA LOMA COCKPIT), FOR THE OPERATION OF ITS BUSINESS FOR A PERIOD OF TWO (2) YEARS COVERING THE CALENDAR YEARS 2003 AND 2004, IN ACCORDANCE WITH EXISTING LAWS, RULES AND REGULATIONS, AND SUBJECT TO THE PAYMENT OF THE CORRESPONDING TAXES, FEES AND OTHER CHARGES THEREFOR.

WHEREAS, the Gallera de Guison Hermanos, Inc. (La Loma Cockpit), established in 1902, has been regularly granted permit to operate its business since 1996, when special permit was granted thereto by virtue of an ordinance introduced by the herein proponent, and its record since its organization speaks well of its fairness in dealing with its clientele;

WHEREAS, the said cockpit holds twelve (12) derbies every year and pintakasis three (3) days per week, i.e., every Thursday, Fridays and Saturdays, or a total of one hundred fifty-six (156) pintakasis;

WHEREAS, this grant of special permit to Gallera De Guison Hermanos, Inc. (La Loma Cockpit), will mean continued remittance by it of the taxes, fees and other charges it currently remits to the City Government, for a period of two (2) years covering the calendar years 2003 and 2004, without danger to the peace and order situation of the City.


