RESOLUTION NO. SP 1920, S-2002

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, AND THE HONORABLE REPRESENTATIVE LIZA L. MAZA, RELATIVE TO THE IMPLEMENTATION OF BAYAN MUNA MEDICAL INDIGENT SUPPORT PROGRAM.

WHEREAS, the Quezon City General Hospital has the facilities that can provide services needed by the indigent patients requesting for medical assistance;



WHEREAS, the immediate ratification of the Memorandum of Agreement would be very beneficial to the less-fortunate constituents of our beloved city.


NOW, THEREFORE,


