RESOLUTION NO. SP-**1921**, S2002

A RESOLUTION URGING THE QUEZON CITY CIVIL REGISTRAR TO UPDATE AND PURSUE WITH MORE VIGOR THE REGISTRATION OF THE UNREGISTERED BIRTHS IN QUEZON CITY, BY HOLDING IT IN THE DIFFERENT BARANGAYS AND TO SUBMIT TO THE CITY MAYOR AND THE CITY COUNCIL A MONTHLY PROGRESS REPORT THEREOF.

WHEREAS, there are still hundreds of children in Quezon City whose actual dates of birth have not been recorded/registered in the Office of the City Civil Registrar, either thru the negligence, ignorance or poverty of their parents;

WHEREAS, these unregistered births will later on bring about problems of identity for said children, especially when they become of school age or apply for work;

WHEREAS, the Quezon City government has the legal and moral obligation to ensure that its residents are properly identified and that their true dates of birth and other personal circumstances are properly documented;

WHEREAS, it will serve the best interest of the public if the Quezon City Civil Registrar expedites and updates the registration of the unregistered births in Quezon City.


NOW, THEREFORE,




