A RESOLUTION URGING THE SECRETARY TO THE SANGGUNIANG (CITY SECRETARY), QUEZON CITY TO FURNISH ALL POLICE STATIONS AND BARANGAY HALLS IN QUEZON CITY A COPY OR COPIES OF EXISTING CITY ORDINANCES, PRINTED IN PAMPHLET OR CAPSULIZED FORM.

WHEREAS, it has been observed that the reason why these ordinances are not properly implemented is because of the fact that members of the police force, as well as the barangay officials are not fully aware of its existence;


WHEREAS, to ensure its successful implementation, these city ordinances must be distributed to the police stations and barangay halls to make our law enforcers aware of the local laws within their jurisdiction;

WHEREAS, the printing of these city ordinances in pamphlet or capsulized form will give out law enforcers the opportunity to bring with them, all the time, a copy thereof so that in the event that somebody or the apprehended person questions some of its provisions or wants to see the copy of the ordinance the law enforcers could easily present it.

NOW, THEREFORE,


