RESOLUTION NO. SP-1926, S'2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE REPUTABLE AND ACCREDITED CONTRACTORS TO UNDERTAKE THE CONSTRUCTION OF A TWO (2) STOREY MULTI PURPOSE HALL LOCATED AT BARANGAY BOTOCAN, QUEZON CITY.



WHEREAS, the barangay officials of Barangay Botocan has requested the construction of a multi-purpose hall in their barangay;

WHEREAS, it is necessary for the City Council to grant an authority to the City Mayor in order for the latter to enter into a negotiated contract with any reputable and accredited contractor to undertake the construction of the two (2) storey multi-purpose hall of Barangay Botocan.



NOW, THEREFORE,




