WHEREAS, Twinstar Professional Protective Services, Inc., on its part is a corporation duly organized and existing by virtue of Republic Act 5487, otherwise known as the Private Security Act and holder of National License No. PSA-00384 — 2001, issued by the Philippine National Police (PNP) with principal address at Units 207 & 208 2/F BSC Building, 77 Malakas Street, Diliman, Quezon City;

WHEREAS, the two Contract for Security Services was for the period covering January 1, 2002 to February 28, 2002 and March 1, 2002 to June 30, 2002;

WHEREAS, both Contract of Security Services entered into by the parties requires the ratification of the Quezon City Council.
