A RESOLUTION URGING THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR., TO CREATE THE QUEZON CITY RESCUE OFFICE, UNDER THE OFFICE OF THE CITY MAYOR FROM BEING A MERE TASK FORCE INTO A REGULAR OFFICE.

WHEREAS, there is a need for the continuous service and assistance rendered by the Quezon City Rescue Task Force, being a hallmark of the city government's effort to deliver one of the basic services to its constituents;

WHEREAS, the guarantee of the continuous existence of the Task Force is by making the Quezon City Rescue Task Force into a regular office under the Office of the City Mayor;

WHEREAS, the creation of the Quezon City Rescue Office and absorbing the present personel complement will boost the morale of its members and will eventually further enhance the services it rendered to its constituents.
