RESOLUTION NO. SP-1929 + \$-2002

A RESOLUTION URGING THE QUEZON CITY MAYOR, HONORABLE FELICIANO R BELMONTE, JR., TO DIRECT THE QUEZON CITY ENGINEER TO CONSTRUCT A COVERED COURT ON THE OPEN SPACE, TECHNICALLY KNOWN AS LOT 23, BLOCK 28 OF KINGSPOINT PARK, KINGSPOINT SUBDIVISION, BARANGAY BAGBAG, NOVALICHES, DISTRICT II, QUEZON CITY.

WHEREAS, Let 23, Block 28 of Kingspoint Subdivision is an open space of 18,453 square meters said to have been donated to and accepted by the Quezon City government on September 22, 1971;

WHEREAS, the said open space has only a small Kingspoint Homeowners Association, Inc., office, an open basketball court and some old children's playground equipment put by the Homeowners Association,

WHEREAS, the said small office has been used as a polling place for national and local elections starting May 14, 2001, resulting to congestion and confusion.

WHEREAS, the Quezon City government has constructed some covered courts and other park amenities in several other subdivisions and barangays;

WHEREAS, the construction of a covered court would greatly benefit not only some 500 families in Kingspoint Subdivision, but also of adjoining subdivisions and pockets of communities at the periphery of the Kingspoint Subdivision.
