RESOLUTION NO. SP **1931**S-2002

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO DIRECT THE CITY AUTHORITIES CONCERNED TO CAUSE THE PAYMENT OF THE 13TH MONTH BONUS AND OTHER CHRISTMAS BENEFITS OF CITY GOVERNMENT EMPLOYEES ON OR BEFORE NOVEMBER 29, 2002 TO ENABLE THE EMPLOYEES TO BUY THEIR HOLIDAY NEEDS WHILE THE PRICES OF COMMODITIES HAVE NOT YET BEEN INCREASED.


NOW THEREFORE,


