BELMONTE, JR., CITY MAYOR, AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REPRESENTED BY ITS DIRECTOR GENERAL DANTE V. LIBAN, DOCKETED AS DOC. NO. 353, PAGE NO. 72, BOOK NO. 67, SERIES OF 2002 IN THE NOTARIAL REGISTER OF NOTARY PUBLIC ATTY. JOSE L. PECSON.

NOW, THEREFORE,


