A RESOLUTION URGING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO ALLOCATE THE AMOUNT OF TWO MILLION THREE HUNDRED THIRTY SIX THOUSAND PESOS (P2,336,000.00) FROM THE INFRASTRUCTURE DEVELOPMENT FUNDS IN THE CITY'S ANNUAL BUDGET FOR THE REPAIR AND REHABILITATION OF THE DAMAGED BRIDGE (NEAR THE CREEK) OF SARMIENTO STREET, BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY


