A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE ACCREDITED CONTRACTORS TO UNDERTAKE THE CONSTRUCTION OF A DAY CARE CENTER LOCATED AT THE SIDE OF TOMAS MORATO ELEMENTARY SCHOOL, BARANGAY KAMUNING, QUEZON CITY.

WHEREAS, Barangay Kamuning is lacking of Day Care Center and the construction of which will redound to the benefit of the children in the area;

WHEREAS, after a series of ocular inspection conducted, the City Engineering Office recommended the construction of a day care center at the side of Tomas Morato Elementary School as the only available site for its construction with a corresponding work plan and detailed estimate of materials and the cost of the project.


NOW, THEREFORE,
