RESOLUTION NO. SP-1944S-2002¹

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO SET A YEAR-LONG, CITYWIDE TALENT SEARCH CONTEST WHERE EVERY BARANGAY SHOULD HAVE PARTICIPATION, CULMINATING DURING THE ANNUAL QUEZON CITY FOUNDATION DAY CELEBRATION.

Establish a city council whose purpose is the promotion of culture and arts, coordinate with government agencies and non-governmental organizations, xxx.";

WHEREAS, there is a need to discover grass-roots talents in singing, dancing, acting and other talents that enhance the technical & artistic aspects of the youth;

WHEREAS, the winning talents shall be indorsed to the Quezon City Performing Arts for eligibility and scholarship grants that will open more opportunities and possibilities for their progress and advancement;

WHEREAS, this talent search is in support to the Quezon City Performing Arts Development Program.


NOW, THEREFORE,


RESOLVED, FURTHER, that copy of this resolution shall be forwarded to the Office of the Mayor of Quezon City for information and appropriate action.


