RESOLUTION NO. SP-1945, S-2002

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED IN CALAMBA STREET NEAR CALAVITE STREET; BARANGAY SAN ISIDRO LABRADOR, DISTRICT I, QUEZON CITY, LAST NOVEMBER 4, 2002, THE AMOUNT TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE GOVERNMENT OR FROM ANY AVAILABLE FUNDS OF THE CITY.

WHEREAS, in the afternoon of November 4, 2002, a fire occurred and blazed the structures at Calamba Street near Calavite Street, Barangay. San Isidro Labrador, District I, Quezon City, leaving about Twenty Five (25) families homeless;

WHEREAS, the City government can express its sympathy and concern by way of providing financial assistance to the victims of the fire.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the victims of the fire that occurred at Calamba Street near Calavite Street, Bgy. San Isidro Labrador, District I, Quezon City, last November 4, 2002, the amount to be taken from the calamity or emergency fund of the City government or from any available fund of the City as follows:

Houseowners	P 2,000.00
House renters/sharers	1,000.00

RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate/authenticate the list of the fire victims categorized into house owners or renters/sharers and to submit the same to the Office of the City Mayor making representation for the early release of the financial assistance to the qualified recipients.


