RESOLUTION NO. SP-1947 S-2002

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE REPAIR/RENOVATION OF THE COMMISSION ON AUDIT (COA) LOCATED AT THE 1ST FLOOR OF THE LEGISLATIVE WING BUILDING, QUEZON CITY HALL.

WHEREAS, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, provides, to wit:

"Every local government unit shall exercise the powers expressly granted x x x as well as powers necessary to x x x promote health and safety, x x x, and preserve the comfort and convenience of their inhabitants"

WHEREAS, there is a need to repair/renovate the building of the Commission on Audit (COA) located at the 1st floor of the legislative wing building, Quezon City Hall;

WHEREAS, the said building has already deteriorated to the point of causing great inconvenience to the government employees working therein and to protect the important records and files placed thereat;

WHEREAS, for this purpose, the city government is seriously considering the plan to renovate the building of the Commission on Audit (COA) for the best interest of the city and the public in general;

WHEREAS, the City Mayor is hereby given the authority to enter into a negotiated contract with any reputable and city accredited construction corporation for the repair/renovation of the Commission on Audit (COA) building.




NOW, THEREFORE,
