A RESOLUTION AUTHORIZING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ALEXA CONSTRUCTION, INC., A DULY ACCREDITED CONSTRUCTION FIRM FOR THE IMPROVEMENT/ASPHALTING OF SEMINARY ROAD ALONG PUGAD LAWIN SHRINE AT BARANGAY BAHAY TORO, QUEZON CITY.

WHEREAS, the Alexa Construction, Inc., a duly accredited construction firm proposed the asphaltting of the road along Pugad Lawin Shrine;




