Resolution No. SP- 1950 S-2002

A RESOLUTION AUTHORIZING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH REPUTABLE SUPPLIERS FOR THE SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS TO BE USED FOR THE CONSTRUCTION OF PATHWALKS ALONG ALLEYS IN THE DIFFERENT BARANGAYS LOCATED IN THE SECOND DISTRICT OF QUEZON CITY IN THE ESTIMATED AMOUNT OF THREE MILLION THREE HUNDRED TWELVE THOUSAND PESOS (P3,312,000.00) TO BE CHARGED AGAINST THE LUMP SUM APPROPRIATIONS FUND UNDER THE OFFICE OF THE CITY MAYOR.


WHEREAS, the construction and improvement of pathwalks along the alleys in the different barangays located in the Second District of Quezon City is among the priority development projects of the Quezon City government;


WHEREAS, such development project is aimed to provide easy, convenient and more comfortable pedestrian access and mobility to and from the interior parts of said barangays;

WHEREAS, time is of the essence in the implementation of said project in the face of the uncertainties and vagaries of weather conditions, and other factors affecting the early completion of said project, including but not limited to the rapidly increasing cost of labor and construction materials;

WHEREAS, there is a sense of urgency, and a felt need to immediately finish said project in order to provide for the comfort and convenience of the residents of said barangays who have long suffered from the existing unattended conditions of said pathwalks;

WHEREAS, in order to avoid unnecessary delay which normally attends public bidding, there is a felt need to authorize the City Mayor of Quezon City, Hon. Feliciano R. Belmonte, Jr., to enter into a negotiated contract with reputable suppliers, for the supply and delivery of construction materials to be used for the improvement and construction of said pathwalks along alleys in the different barangays of the Second District of Quezon City;







WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, Quezon City Mayor, Hon. Feliciano R. Belmonte, Jr., to enter into a negotiated contract with reputable suppliers for the supply and delivery of construction materials to be used for the construction of pathwalks along alleys in the different barangays located within the Second District of Quezon City, estimated in the amount of P3,312,000.00 to be charged against the lump sum appropriations fund under the Office of the City Mayor.


