RESOLUTION NO. SP-**1955**S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE REPUTABLE AND ACCREDITED CONTRACTORS TO UNDERTAKE THE CONSTRUCTION OF A ONE (1) STOREY MULTI PURPOSE HALL LOCATED AT BARANGAY OBRERO, QUEZON CITY.

WHEREAS, the barangay officials of Barangay Obrero has requested the construction of a Multi Purpose Hall in their barangay;

WHEREAS, the Multi Purpose Hall will be used as the site for the other activities of the barangay and will serve as an extension of the Barangay Hall;

WHEREAS, the Office of the City Engineer has conducted an ocular inspection on the site of the proposed Multi Purpose Hall;

WHEREAS, the Office of the City Engineer has recommended the construction of the said project and in fact prepared a program of work and detailed estimate for the proposed construction of the one (1) storey Multi Purpose Hall located in the same barangay;

WHEREAS, it is necessary for the City Council to grant an authority to the City Mayor in order for the latter to enter into a negotiated contract with any reputable and accredited contractor to undertake the construction of the one (1) storey Multi Purpose Hall of Barangay Obrero.


