RESOLUTION NO. SP- **1957** 'S2002

A RESOLUTION URGING THE HONORABLE MAYOR FELICIANO R. BELMONTE, JR., TO MAKE AN OFFER TO BUY THE RESIDENTIAL LAND LOCATED AT NO. 75 SAN ANTONIO ST., BARANGAY SAN ANTONIO, AREA II, DISTRICT I, QUEZON CITY, REGISTERED IN THE NAME OF MR. GUMBERT A. GUMBLER WITH T.C.T. NO. 37145, CONTAINING AN AREA OF ONE THOUSAND TWO HUNDRED NINETY-THREE (1,293) SQUARE METERS, MORE OR LESS, TO ALLOCATE SUFFICIENT AMOUNT FOR ITS ACQUISITION AND EVENTUALLY SELL TO THE OCCUPANT THEREIN THRU THE COMMUNITY MORTGAGE PROGRAM.

WHEREAS, the Sangguniang Barangay of Barangay San Antonio in session assembled requested the City Council to expropriate the residential land registered in the name of Mr. Gumbert A. Gumbler with T.C.T. No. 37145 containing an area of 1,293 square meters, more or less;

WHEREAS, it is but proper to make first an offer to buy the above described property in order to save time, effort and expenses on the city government;

WHEREAS, the City Council of Quezon City has decided to make representation with the Hon. Mayor Feliciano R. Belmonte, Jr. to undertake measures to buy the property described in the first whereas clause.

NOW, THEREFORE,


