RESOLUTION NO. SP-1958-2002

A RESOLUTION REQUESTING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF THREE HUNDRED NINETY THOUSAND ONE HUNDRED THIRTEEN PESOS AND NINETY-THREE CENTAVOS (P390,113.93) FOR THE ASPHALT OVERLAY OF A TRICYCLE LANE AT MISAMIS EXTENSION STREET, BARANGAY STO. CRISTO, QUEZON CITY, THE SAID AMOUNT TO BE TAKEN FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, Section 458(a)(5)(v) of RA 7160, otherwise known as the local Government Code of 1991, states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances which shall ensure the efficient and effective delivery of the basic services and facilities; shall regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same".

WHEREAS, there is an urgent need for the asphalt overlay of a tricycle lane of Misamis Extension Street, Barangay Sto. Cristo, Quezon City, to have the safety and convenience of innumerable people passing of the road;

WHEREAS, the City Engineer has estimated that the project will cost P390,113.93 that includes, sectional squaring, patching, spreading of bituminous prime coat and asphalt overlay of pavement, which amount is not available in any existing appropriation.


NOW, THEREFORE,

Cristo, Quezon City, the said amount to be taken from any available fund of the City Treasury.




