RESOLUTION NO. SP-1960, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND ACCREDITED CONTRACTOR TO UNDERTAKE THE ASPHALTING OF MALINIS ST. IN BARANGAY U.P. VILLAGE, MATIMTIMAN ST. IN BARANGAY TEACHER'S VILLAGE WEST, MADASALIN ST. OF BARANGAY SIKATUNA, AND THE U.P. CONSUMERS COOPERATIVE AREA IN BARANGAY U.P. CAMPUS, QUEZON CITY.

WHEREAS, the barangay officials of Barangay U.P. Village, Barangay Teacher's Village West, Barangay Sikatuna and the Officers of U.P. Credit Cooperative Union of Barangay U.P. Campus requested for the asphaltting of roads in their respective areas leading to Malinis St., Matimtiman St., Madasalin St., and the U.P. Consumers Cooperative Area, respectively;

WHEREAS, the road improvements to be introduced in the said areas shall greatly help in easing traffic congestions and give easy access to people in the said communities;

WHEREAS, the road conditions of the said areas have been in a very deplorable state for several years and have been the major causes of various vehicular troubles and accidents endangering, therefore, precious lives, limbs and properties;

WHEREAS, the Office of the City Engineer has conducted an ocular inspection of the aforesaid site and has prepared the appropriate Individual Projects Program of Work;

WHEREAS, it is necessary for the City Council to grant an authority to the City Mayor in order for the latter to enter into a negotiated contract with any reputable and accredited contractor to undertake the road asphaltting of Malinis St., Matimtiman St., Madasalin St., and the U.P. Consumers Cooperative Area, located in Barangay U.P. Village, Barangay Teacher's Village West, Barangay Sikatuna and Barangay U.P. Campus, respectively.



NOW, THEREFORE,




