RESOLUTION NO. SP- **1961**, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE IMPROVEMENT, REHABILITATION, AND UPGRADING OF COVERED BASKETBALL COURTS IN BARANGAYS MASAGANA, GULOD, BAESA, SAUYO AND MALIGAYA, ALL IN QUEZON CITY, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

Introduced by Councilors ELIZABETH A. DELARMENTE, VOLTAIRE GODOFREDO L. LIBAN III, AIKO MELENDEZ-YLLANA, RAMON P. MEDALLA, ALLAN BUTCH T. FRANCISCO, ERIC Z. MEDINA and MARY ANN L. SUSANO.

WHEREAS, Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides, to wit:

"Every local government unit shall exercise the powers expressly granted x x x as well as powers necessary to x x x, promote health and safety, x x x, and preserve the comfort and convenience of their inhabitants."

WHEREAS, there is a need to improve, rehabilitate and upgrade the covered basketball courts in Barangays Masagana, Gulod, Baesa, Sauyo and Maligaya, all in Quezon City;

WHEREAS, the said covered basketball courts have already deteriorated to the point of causing great inconvenience and danger to the lives of the residents therein;

WHEREAS, these dilapidated covered basketball courts need to be addressed by the city government, to prevent the unnecessary loss of lives among its constituents;

WHEREAS, for this purpose, the city government is seriously considering the plan to improve, rehabilitate and upgrade the covered basketball courts in Barangays Masagana, Gulod, Baesa, Sauyo and Maligaya, for the best interest of the city and the public in general;


WHEREAS, the City Mayor is hereby given the authority to enter into a negotiated contract with any reputable and city accredited construction corporation for the improvement, rehabilitation and upgrade the covered basketball courts in Barangays Masagana, Gulod, Baesa, Sauyo and Maligaya, all in Quezon City.

NOW, THEREFORE,




