RESOLUTION NO. SP-**1962**, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE ASPHALT OVERLAYING OF HARVARD STREET, BARANGAY RODRIGUEZ, DISTRICT III, QUEZON CITY.

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991, provides that:

"Every local government unit shall exercise the powers expressly granted x x x as well as powers necessary to x x x, promote health and safety, x x x, and preserve the comfort and convenience of their inhabitants."


WHEREAS, there is need to improve and rehabilitate Harvard Street, Barangay Rodriguez, District III, Quezon City;


WHEREAS, the said street has already deteriorated to the point of causing great inconvenience to the motorists and residents passing therein;

WHEREAS, the dilapidated city roads/streets need to be addressed by the city government, to prevent the unnecessary loss of lives among its constituents;

WHEREAS, for this purpose, the city government is seriously considering the plan to improve and rehabilitate Harvard Street, Barangay Rodriguez, for the best interest of the city and the public in general;

WHEREAS, the City Mayor is hereby given the authority to enter into a negotiated contract with any reputable and city accredited construction corporation for the asphalt overlaying of Harvard Street, Barangay Rodriguez, District III, Quezon City.




