RESOLUTION NO. SP-1971, S²-2002

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR ACCREDITED BY THE LOCAL GOVERNMENT OF QUEZON CITY FOR THE RENOVATION AND REPAIR OF THE LIGA NG MGA BARANGAY OFFICES, AT SUCH AMOUNT NOT EXCEEDING THEIR COST ESTIMATES TO BE CHARGED AGAINST THE LUMP SUM APPROPRIATION OF FUND OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the proposed repair and renovation of the Liga ng mga Barangay Offices have been sought to be undertaken among others, by the City government to promote the welfare and convenience of the city residents, for the orderly transaction of public business, for the effective and efficient undertaking of public duty as mandated by law;

WHEREAS, time is of the essence due to the urgency of the above-proposed projects, the rising cost of labor and materials, and to avoid unnecessary delay in attending to the normal conduct of public bidding, it is deemed expedient that the City government enters into a negotiated contract for the early completion of the above-stated projects;

WHEREAS, no less than the prestige of public service is at stake, it being that the city residents would feel greater pride and privilege in transacting business affecting their concerns, and that of the city in general, if they feel comfort and convenience within the premises wherein they do so;


WHEREAS, pursuant to Section 455 (b) (1) (vi) of RA 7160, otherwise known as the "Local Government Code of 1991," the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any reputable contractor accredited by the Local government of Quezon City for the renovation and repair of the Liga ng mga Barangay Offices, at such amount not exceeding its cost estimate to be charged against the Lump Sum of Appropriation of Fund of the Office of the City Mayor, subject to existing auditing and accounting rules and regulations.
