RESOLUTION NO. SP 1972, S-2002

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE CONSTRUCTION OF A PEDESTRIAN OVERPASS AT COMMONWEALTH AVENUE CORNER IBP LITEX ROAD, BARANGAY COMMONWEALTH, DISTRICT II, QUEZON CITY.

WHEREAS, Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that:

"Every local government unit shall exercise the powers expressly granted $x \times x$ as well as powers necessary to $x \times x$, promote health and safety, $x \times x$, and preserve the comfort and convenience of the inhabitants."

WHEREAS, there are number of reported cases of road accidents involving pedestrians along Commonwealth Avenue, District II, this City, corner IBP Litex;

WHEREAS, these related road accidents need to be addressed by the city government to prevent the unnecessary loss of lives among its constituents;

WHEREAS, for this purpose, the city government is seriously considering the plan to construct a pedestrian overpass along Commonwealth Avenus for the best interest of the city and the public in general;

WHEREAS, the City Mayor is hereby given the authority to enter into a negotiated contract with any reputable and city accredited construction corporation for the construction of the pedestrian overpass along Commonwealth Avenue, corner IBP Litex.
