RESOLUTION NO. SP-1973s-2002

A RESOLUTION URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE JR., TO INSTALL STREETLIGHTING FACILITIES, REHABILITATE AND BEAUTIFY THE PLAYGROUND AREA AT UP VILLAGE PARK, QUEZON CITY.

WHEREAS, Section 458 (5) (v) of RA 7160, otherwise known as the Local Government Code of 1991 states that the City government through an ordinance enacted for the general welfare of the city and its inhabitants, shall regulate the parks and other public places and shall approve the construction, improvement, repair and maintenance of the same;

WHEREAS, maintaining a well-functioning streetlights and/or street lamps is vital for the night time safety of the residents of the UP Village in Quezon City;

WHEREAS, the rehabilitation of the playground area will provide the youth a place for recreation and, therefore, creating an avenue to keep them away from undesirable vices unnecessary for youth development;

WHEREAS, this Ordinance supports the objective of the City government in upgrading, restoring and/or rehabilitating parks in Quezon City for public utility and for the general welfare of the citizens of the City;

WHEREAS, this Ordinance supports the requests of the residents and barangay officials of Barangay UP Village in accordance with Section 391 (a) (5) of RA 7160, otherwise known as the Local Government Code of 1991 that states that the Sangguniang Barangay shall submit to the Sangguniang Panlungsod such suggestions or recommendations as it may see fit for the improvement of the barangay or for the welfare of the inhabitants thereof.
