RESOLUTION NO. SP 1975-2002

A RESOLUTION URGING EVERY COMPONENT BARANGAY OF QUEZON CITY TO SET ASIDE AND APPROPRIATE THE SUM OF THREE THOUSAND TWO HUNDRED AND TWENTY PESOS (P3,220.00) EVERY YEAR IN ITS ANNUAL BUDGET AS CONTRIBUTION TO THE LIGA NG MGA BARANGAY KAGAWAD NG LUNGSOD QUEZON.

WHEREAS, the Barangay Kagawad of the 142 component Barangays of Quezon City, in response to Resolution No. SP-1031, S-98, have organized themselves into an association in order to assist the barangays and the City government in undertaking an effective and efficient government;

WHEREAS, the Liga ng mga Barangay Kagawad Constitution and By-Laws was ratified and approved by all the kagawads of Quezon City, upon proper and due notice in a general assembly called for the purpose last October 2, 1999 at the Philam Homes Covered Court, Quezon City;

WHEREAS, the Board of Trustees and officers of the Liga ng mga Barangay Kagawad ng Lungsod Quezon passed and adopted a Resolution requesting that every component barangay of Quezon City contribute the sum of Three Thousand Two Hundred and Twenty Pesos (P3,220.00) per annum representing annual membership fee of each barangay and their contribution to the Damayan Fund;




NOW, THEREFORE,


