A RESOLUTION GRANTING AMUSEMENT TAX EXEMPTION TO THE UNIVERSITY ATHLETIC ASSOCIATION OF THE PHILIPPINES (UAAP) ON EARNINGS FROM TICKET SALES FOR THE BASKETBALL TOURNAMENT SCHEDULED FROM 13 JULY, 2002 ONWARDS

WHEREAS, the University Athletic Association of the Philippines (UAAP) is opening its 65<sup>th</sup> Season on 13 July, 2002, with a basketball tournament among its members, an event which has become increasingly popular among the general public, especially college students;

WHEREAS, the earnings derived from ticket sales for this event are used by the Association to subsidize the expenses in holding tournaments involving other less popular sports to increase awareness and interest in them;

WHEREAS, the UAAP is requesting that they be granted an exemption from the payment of amusement tax on such earnings, which exemption had been granted to them in the past on the basis of Ordinance No. SP-551, S-1997 and the Local Government Code of 1991, specifically, Book II and Section 458 thereof;


WHEREAS, the Quezon City government should encourage the Association and other similar organizations in engaging the City's youth in sports and friendly competition, and in developing athletes to represent the City not only in local but also in international sporting events.
