RESOLUTION NO. SP-**1984**, 'S-2003

A RESOLUTION URGING THE CONGRESS OF THE PHILIPPINES TO AMEND SECTION 457, ARTICLE III OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, TO INCLUDE A SECTORAL REPRESENTATIVE FOR THE ELDERLY.

WHEREAS, paragraph (a) section 457 of the Local Government Code provides for the inclusion of the president of the panlungsod na pederasyon ng mga Sangguniang Kabataan to the Sangguniang Panlungsod;

WHEREAS, it will be to the advantage of local government units to have the representation of the elderly for them to share the wisdom of their experience with the local legislative branch;


WHEREAS, this proposed amendment to Republic Act 7160, would bring together the fresh ideas and idealism of the youth and the wisdom and experience of the elderly.

NOW, THEREFORE,


