A RESOLUTION REITERATING THE STRONG SENTIMENT OF THE QUEZON CITY COUNCIL CONTEMPLATED IN RESOLUTION NO. NC-498, S-90, REQUESTING THE OFFICE OF THE OMBUDSMAN TO ASSIGN RESIDENTIAL TANODBAYANS FOR QUEZON CITY.




NOW, THEREFORE,
