RESOLUTION NO. SP-**1989**, §-2003

A RESOLUTION DIRECTING THE HEAD OF THE ENVIRONMENTAL PROTECTION AND WASTE MANAGEMENT DEPARTMENT (EPWMD), QUEZON CITY, TO CALL THE ATTENTION OF THE CITY GARBAGE CONTRACTORS OR THEIR REPRESENTATIVES TO THE UNMITIGATED SOLICITATIONS BEING IMPOSED BY GARBAGE COLLECTION CREWS UPON CITY RESIDENTS AND BUSINESS ESTABLISHMENTS.

WHEREAS, numerous complaints have been received by the city government from residents and business establishments against garbage collectors who under various pretexts, solicit from them contributions in cash or in kind to the irritation and annoyance of those concerned;

WHEREAS, the Quezon City Government has never given any permission, tacit or implied, for said solicitations which may be violative of existing laws;

WHEREAS, it is to the best interest of the City if its residents and business establishments are spared from such shenanigans;

WHEREAS, the city garbage contractors should be forewarned that if they persist in committing said illegal acts their case shall be prosecuted before the City Prosecutor's Office.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to direct, as it does hereby direct, the Head of the Environmental Protection and Waste Management Department (EPWMD), Quezon City, to call the attention of the city garbage contractors or their representatives to the unmitigated solicitations being imposed by garbage collection crews upon city residents and business establishments.
