RESOLUTION NO. SP-19903-2002

A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO APPROPRIATE THE AMOUNT OF THREE HUNDRED SIXTY-EIGHT THOUSAND ONE HUNDRED THIRTY-SEVEN & 77/100 PESOS (P368,137.77) FROM THE INFRASTRUCTURE FUNDS OF THE ANNUAL CITY BUDGET FOR THE CONSTRUCTION OF A CONCRETE FOOTBRIDGE IN AREA 5, SITIO VETERANS, BAGONG SILANGAN, QUEZON CITY.

WHEREAS, Area 5, Sitio Veterans, Brgy. Bagong Silangan, this city, is a community that can not be reached by 4-wheel vehicles and the only access of the 400 families or so living thereat is through a wooden footbridge which unfortunately collapsed due to rapid flow of water during the past rainy season, isolating the residents from neighboring communities and leaving them in a miserable and precarious situation;

WHEREAS, after an ocular inspection, the Office of the City Engineer recommended that a new concrete footbridge be constructed as replacement for the collapsed footbridge;

WHEREAS, as per Program of Work and Detailed Estimate prepared by the Office of the City Engineer, the above-stated concrete footbridge will cost Three Hundred Sixty-Eight Thousand One Hundred Thirty-Seven Pesos & 77/100 Pesos (P368,137.77), copy is attached hereto as Annex "A".
