RESOLUTION NO. SP-1991s-2003

A RESOLUTION DIRECTING THE OFFICE OF THE CITY ENGINEER TO CONDUCT AN INSPECTION OF ALL DAY CARE CENTERS IN QUEZON CITY TO DETERMINE THE REPAIR NEEDS OF THESE CENTERS, INCLUDING THE NECESSARY FACILITIES TO BE INSTALLED THEREAT, AND TO SUBMIT TO THE CITY COUNCIL THE BUDGETARY REQUIREMENTS THEREFOR WITHIN A REASONABLE TIME FROM RECEIPT OF THIS RESOLUTION.

WHEREAS, it has come to the knowledge of some members of the City Council that some day care centers are in a state of disrepair;

WHEREAS, immediate repair must be undertaken on these centers to prevent any danger or harm from befalling our residents, especially our children;

WHEREAS, day care centers contribute to the well-being of our children and should be maintained and utilized to the fullest extent.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to direct, as it does hereby direct, the Office of the City Engineer to conduct an inspection of all day care centers supervised by the Quezon City, government to determine the repair needs of these structures and cost estimate, including the necessary facilities to be installed thereat.

RESOLVED, FURTHER, to instruct the City Engineer to submit to the City Council within a reasonable time from receipt of a copy of this resolution the budgetary requirements needed for the repair of the day care centers.






