RESOLUTION NO. SP-1997S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO MORE THAN EIGHT HUNDRED FORTY-SEVEN (847) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA IN ERMIN GARCIA ST., BARANGAY E. RODRIGUEZ, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM ANY OTHER AVAILABLE FUND IN THE CITY TREASURY.

NOW, THEREFORE,


