RESOLUTION NO. SP 2001 S-2002

A RESOLUTION URGING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO ALLOCATE FROM ANY AVAILABLE FUNDS THE AMOUNT OF TWO HUNDRED FORTY-ONE THOUSAND FOUR HUNDRED ONE PESOS AND FOURTEEN CENTAVOS (P241,401.14) FOR THE CONSTRUCTION OF TWO (2) WAITING SHEDS IN BARANGAY STA. CRUZ, QUEZON CITY.

Introduced by Councilors BERNADETTE HERRERA-DY, VINCENT P. CRISOLOGO, WILMA AMORANTO-SARINO, VICTOR V. FERRER, JR., ELIZABETH A. DELARMENTE and ROMMEL R. ABESAMIS.

WHEREAS, pursuant to Section 458 (a)(5)(v) of RA 7160, otherwise known as the Local Government Code of 1991, provides that, "The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants x x x

"(5) Approved ordinances which shall ensure the efficient and effective x x x (v) Regulate the use of the streets, avenues, alleys, sidewalks, bridges, parks and other public places and approved the construction, improvement, repair and maintenance of the same; x x x."

WHEREAS, there is an urgent need for the construction of two (2) waiting sheds in Barangay Sta. Cruz, Quezon City, one at the corner of Gen. Segundo Street and Roosevelt Ave. area and another at the frontage of the Pantranco Property along Roosevelt Avenue that will redound to the benefit of the residents of the said barangay in particular and to Quezon City in general;

WHEREAS, the City Engineer has estimated that the project will cost Two Hundred Forty-One Thousand Four Hundred One Pesos and Fourteen Centavos (P241,401.14).
