RESOLUTION NO. SP **2002**S-2003

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO DIRECT THE QUEZON CITY TRICYCLE REGULATORY UNIT TO ADOPT A NON-EXPENSIVE UNIFORM FOR LICENSED TRICYCLE DRIVERS PLYING A PARTICULAR APPROVED TRICYCLE ROUTE IN ANY BARANGAY OR SUBDIVISION WITHIN QUEZON CITY, AND ADOPTING APPROPRIATE COLOR SCHEMES FOR THE PURPOSE.

WHEREAS, there are many commuters who avail of the use of tricycles as an inexpensive means of transportation within the subdivisions or barangays in Quezon City;

WHEREAS, the Quezon City Tricycle Regulatory Unit is charged with the task of issuing the necessary rules and regulations, and the implementation thereof, which are intended to provide order and safety in the use of tricycles as a means of transportation;

WHEREAS, the wearing of uniforms by tricycle drivers will serve the purpose of easy identification of said drivers which will facilitate their immediate apprehension for any lawful purposes;

WHEREAS, the wearing of tricycle drivers' uniform with a particular color scheme for every approved tricycle route, will enhance aesthetic impact and image of order and discipline.
