RESOLUTION NO. SP-2004, s-2003

A RESOLUTION URGING THE MAYOR OF QUEZON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BARANGAY CENTRAL TO ALLOW THE USE OF A PORTION OF THE PROPERTY OF THE QUEZON CITY HALL COMPOUND AS A PERMANENT SITE OF THE BARANGAY HALL.

WHEREAS, the barangay is the basic unit of the government;

WHEREAS, Barangay Central, District IV, Quezon City, occupies a portion of the property of Quezon City Hall of which it has been occupying for so many years;

WHEREAS, the Barangay Council of Central would like to have the said portion be granted through a Memorandum of Agreement with the City government for a period of twenty-five (25) years renewable for another twenty-five years through the consent of both parties;

WHEREAS, the existing site shall not be used for any other purpose other than that of a barangay hall;

Handwritten initials and signatures, including "WB" and "A", are present on the right side of the page.

Handwritten initials "Dmg" are present in the bottom left corner.

WHEREAS, the Barangay Council of Barangay Central plan to improve its Barangay Hall renewable for another 25 years for which reason it needs a permanent place for its construction;

WHEREAS, the subject property shall be limited to the existing area presently occupied by the barangay hall of Barangay Central.


NOW, THEREFORE,
