RESOLUTION NO. SP **2011**'s-2003

A RESOLUTION URGING ALL BARANGAY COUNCILS WITHIN THE JURISDICTION OF QUEZON CITY TO ADOPT AND ESTABLISH THEIR ARCHIVAL SYSTEM AS MANDATED BY THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Section 374 of the Local Government Code mandates that:

“Every local government unit shall provide for the establishment of an archival system to ensure the safety and protection of all government property, public documents or records such as records of births, marriages, property inventory, land assessments, land ownership, tax payments, tax accounts, and business permits, and such other records or documents of public interest in the various departments and offices of the provincial, city or municipal government concerned.”

WHEREAS, the Barangay is the smallest political unit possessing its own property, public documents and records necessary in the performance of its governmental functions.
