WHEREAS, an endorsement from the Quezon City Council will further strengthen the many resolutions/letters of endorsement of the various city and municipal councils in Metro Manila, a confirmation of the laws and concerted efforts of the MMPCL, its officers and members, to update the league's Constitution and By-Laws for the greater welfare and interest of the general membership and all concerned.




