RESOLUTION NO. SP. 2018, S-2003

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED AT BAESA ROAD CORNER QUIRINO HIGHWAY, NOVALICHES, QUEZON CITY.

WHEREAS, petitioner Petron Corporation, a duly registered juridical entity, is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of one of its gasoline service station as part of the expansion program of its facilities in Quezon City, has identified a particular area located at Baesa Road corner Quirino Highway, Novaliches, Quezon City;

WHEREAS, gasoline service stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Petron Corporation has complied with the requirements for the issuance of a Special Permit as required by the said Ordinance;

WHEREAS, the construction and operation of said gasoline station will promote public welfare and economic development, through the projected increase of employment opportunities in our city.
