A RESOLUTION GIVING POSTHUMOUS AWARD OF HEROISM TO THE LATE SPO3 JESUS BRACIA OF FERIA ROAD, BARANGAY OLD BALARA, QUEZON CITY, FOR SACRIFICING HIS LIFE IN THE DISCHARGE OF HIS DUTY AS A POLICE OFFICER.

WHEREAS, SPO3 Jesus Bracia is a police officer in the active service for more than fifteen (15) years and was assigned at Station 6 (Batasan Hills), Central Police District Command (CPDC) from July 2000, until his untimely death on April 28, 2002;

WHEREAS, the late SPO3 Jesus Bracia died in the line of duty from hacked and stabbed wounds while responding to prevent a violent confrontation between his quarreling neighbors;

WHEREAS, the sacrifice of life in the line of duty should be given recognition as the ultimate act of heroism;


