A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO FACILITATE THE REPAIR OF THE STREET LIGHTING ALONG KATIPUNAN AVENUE FROM SANTOLAN ROAD TO THE CORNER OF P. TUAZON STREET, AND ARANETA AVENUE FROM AURORA BOULEVARD TO QUEZON AVENUE.


