RESOLUTION NO. SP 2023, S-2003

A RESOLUTION STRONGLY URGING THE CITY MAYOR TO DISPOSE AND AWARD THE LOT CONTAINING, MORE OR LESS, ONE THOUSAND FIVE HUNDRED TWENTY-NINE (1,529) SQUARE METERS COVERED BY TCT NO. 157564 ISSUED IN THE NAME OF THE QUEZON CITY GOVERNMENT, LOCATED AT BUENAMAR SUBDIVISION, NOVALICHES PROPER, QUEZON CITY, TO THE FAMILIES OCCUPYING THE SAME AT REASONABLE COST, SUBJECT TO EXISTING RULES AND REGULATIONS ON SOCIALIZED HOUSING.

WHEREAS, the Sangguniang Barangay of Barangay Novaliches Proper has adopted a resolution strongly urging the Honorable City Mayor, to cause and implement the conversion of public lot intended for market site into a residential area located at Buenamar Subdivision, Novaliches Proper, Quezon City, for the present occupants thereat;

WHEREAS, the concerned residents/occupants thereat are petitioning the Quezon City government through the Peoples' Bureau to have this lot awarded to them;

WHEREAS, the request is meritorious and that the Quezon City government should not turn its back on this problem considering that these forty-six (46) families were occupying the same for so long;
