RESOLUTION NO. SP 2024, S-2003

A RESOLUTION REQUESTING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE AN AMOUNT OF FOUR HUNDRED SIXTY-SIX THOUSAND EIGHT HUNDRED THREE PESOS AND ELEVEN CENTAVOS (P466,803.11) FOR THE IMPROVEMENT OF THE ALLEY AT LOT 5, BARANGAY SAN ANTONIO, QUEZON CITY, TO BE TAKEN FROM ANY AVAILABLE FUNDS.

WHEREAS, Section 458(a)(5)(v) of RA 7160 otherwise known as the Local Government Code of 1991 states that, "the sangguniang panlungsod, as the legislative body of the city, shall enact resolutions and ordinances which shall ensure the efficient and effective delivery of the basic services and facilities; shall regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same";

WHEREAS, the occupants/awardees of the Nagmamahal Lot 5, Inc. of Barangay San Antonio have already paid the amount of Nine Hundred Eighty-Three Thousand Three Pesos and Ninety-One Centavos(P 983,003.91) as of January 2003;

WHEREAS, there is a need for the improvement of the alley at Lot 5, Barangay San Antonio to have a drainage system for the safety and convenience of innumerable people in the barangay;

WHEREAS, the City Engineer has estimated that the project will cost P446,803.11 which includes: excavation for structure, aggregate base course, concreting of pathwalk, and two(2) layers of CHB lined canal with perforated cover.
