RESOLUTION NO. SP- 2029, S-2003

A RESOLUTION URGING THE NATIONAL HOUSING AUTHORITY (NHA) TO DISPOSE AND AWARD THE LOTS LOCATED AT THE BORDERS NEAR THE BANKS OF SAN FRANCISCO RIVER IN 119 KALIRAYA STREET, BARANGAY TATALON, QUEZON CITY, TO THE PRESENT OCCUPANTS THEREAT, SUBJECT TO EXISTING RULES AND REGULATIONS ON SOCIALIZED HOUSING.




NOW, THEREFORE,
